South Fork Peak Savers Rebate Requirements:

- Must be a PSEG Long Island residential customer. No limit per residential account. Must be installed within the following zip codes: 11930, 11932, 11937, 11954, 11962, 11963, 11968, 11975, 11976, 11969 AND residing East of the Shinnecock Canal
- Must be a currently listed ENERGY STAR Variable-Speed Pool Pump, ½ horsepower or larger
- Pump must be installed by a current, participating PSEG Long Island dealer/installer who has completed the 2018 Letter of Agreement and obtained a manufacturer's training certificate
- Rebate purchase(s) must be postmarked within 45 days of installation but no later than December 31, 2018

South Fork Peak Savers Rebate Documents for Submittal:

- Installation contractors are encouraged to submit rebate applications directly, no customer signature is required
 - Record the PSEGLI electric account number or alternatively the nine digit meter number(located on the face of the electric meter) from the residential address where the pumps are installed. Include a copy of the customers electric utility bill if available
 - Submit South Fork Peak Savers rebate application along with a copy of a paid sales receipt showing the model number, installation date and purchase price for each eligible pump
 - If the project contains more pumps than the rebate form accommodates, attach another application to the submission and populate only the equipment fields

- ✓ Include a copy of a paid sales invoice showing the model number, installation date and purchase price for each eligible pump
- ✓ Submit the corresponding rebate applications to both PSEGLI and South Fork Peak Savers to get the maximum rebate.
